The EnviroDevelopment Professional program is designed to provide formal recognition of property development professionals who have undertaken a course in EnviroDevelopment and are part of a sustainability network.

Who can become a member?

Membership Categories

Corporate Membership

Companies that service or participate in the development industry including product manufacturers and suppliers, and service suppliers (consultancies).

Development companies are unable to join as Corporate Members However, development managers may undertake the training course to gain an understanding of the EnviroDevelopment standards in place which may benefit their design processes and understanding of certification.

Associate Membership

Educational bodies, government departments and other government bodies.

Individual Membership

Individual consultants who service and/or participate in the development industry, and hold a tertiary qualification relevant to the property industry. Sustainability and associated professionals working for development companies (e.g. sustainability managers etc.) may be eligible for individual membership.

Student Membership

Student applicants must be a full-time tertiary student undertaking studies relevant to the property industry and/or environmental sustainability.

Envirodevelopment Professional Training Course

To be recognised as an EnviroDevelopment Professional, an individual must attend the half-day EnviroDevelopment Professional training course in order to gain the necessary working knowledge of EnviroDevelopment.

It is expected that an EnviroDevelopment Professional should:

- have sufficient knowledge of the EnviroDevelopment Technical Standards and certification process to act as advisors to their clients on EnviroDevelopment;
- have sufficient knowledge of the EnviroDevelopment application form requirements to be able to complete the form or request the appropriate input from other consultants to complete the form; and
- liaise with the EnviroDevelopment team whenever issues or questions arise.

The course focuses on the content of the EnviroDevelopment National Technical Standards, certification process, case studies and practical application of EnviroDevelopment to a range of development types.

A refresher EnviroDevelopment training course may be required to be undertaken when significant changes are made to the EnviroDevelopment National Technical Standards.
